
LAW TO PROTECT CHILDREN FROM SEXUAL PREDATORS STALLS IN U. S. SENATE

**Homosexual activists' efforts to amend
the bill with a Hate Crimes law is hurting
passage of Children's Safety Act**

The Children's Safety Act of 2005 (H.R. 3132), extensive legislation designed to protect children from sex offenders, has stalled in the United States Senate Committee on the Judiciary.

The U.S. House of Representatives approved the Children's Safety Act on September 14, 2005 by a vote of 371 to 52. The Children's Safety Act of 2005 provides mandates and resources that would significantly protect children from sexual predators and sex offenders.

A&E CHANNEL CANCELS SCHEDULED AIRING OF "PLAYBOY'S CELEBRITY CENTERFOLDS"

The A&E Channel cancelled the airing of their porn special called "Playboy's Celebrity Centerfolds" after advertisers received a flood of emails from Florida Family Association's recent email campaign. FFA's email campaign influenced the removal of FOUR (4) hours of pornographic programming from a network that is available in 200 MILLION HOMES.

FFA sent out an email on Monday, November 28th asking concerned citizens to send emails to thirteen companies that advertised on an A&E television program called "Inside the Playboy Mansion." This program aired on November 23rd from 9:00 to 11:00

ENTERTAINMENT CHANNEL PULLS HOWARD STERN SHOW

The Entertainment Channel (E!) stopped airing The Howard Stern Show on their television cable network starting January 1, 2006. The Entertainment Channel had aired this very pornographic program on average ten (10) hours per week for the past five years.

Florida Family Association (FFA) monitored the Howard Stern Show on the Entertainment Channel for the past five years. FFA wrote thousands of letters to companies that advertised. FFA's monitoring efforts influenced over 2,500 companies to stop advertising on this program. Almost every mainstream company had pulled their advertisements off the Entertainment Channel during the airing of The Howard Stern.

VH1 CHANNEL CANCELS SCHEDULED AIRING OF "CENTERFOLD BABYLON"

The VH1 channel cancelled their television program called Centerfold Babylon that was scheduled to air Tuesday, December 6th at 1:30 AM. VH1 is a music channel, owned by Viacom, Inc., that is available in 84 Million homes. The program "Centerfold Babylon" profiles the lives of several porn actors.

The program Centerfold Babylon appeared on the TVGuide.com Listing Grid during the last week of November. The program was scheduled at that time to air on December 6th at 1:30 AM. However, Centerfold Babylon was removed from the TVGuide.com Listing Grid at the same time A&E removed "Playboy's Celebrity Centerfolds" from the Listing Grid as reported in the adjacent article.

The tragic assaults on Jessica Lunsford and Sarah Lunde by registered sex offenders in Florida motivated eighty eight members of congress to sponsor comprehensive legislation to protect children from future assaults. However, homosexual activists have preyed upon this legislation with an amendment designed to further their agenda even at the cost of protecting children from sexual predators.

Homosexual activists influenced the U.S. House of Representatives to vote 223 to 199 to add Hate Crimes legislation to the Children's Safety Act prior to their approval of the full bill on September 14, 2005. Homosexual activists want the Hate Crimes bill to further their agenda to force Americans to accept their sexual lifestyle as normal.

The Children's Safety Act of 2005 (H.R. 3132) was received in the Senate and referred to the United States Senate Committee on the Judiciary on September 15, 2005. Some insiders contend that confirmation hearings that began in September for John Roberts' nomination to the U.S. Supreme Court delayed the hearing for the Children's Safety Act. Additionally, the first scheduled meeting for the United States Senate Committee on the Judiciary this year, January 9, 2006, starts the confirmation hearings for the nomination of Samuel Alito, Jr. to the U.S. Supreme Court. This will cause further delay in hearing the Children's Safety Act.

However, the attempts by homosexual activists to influence the U.S. Senate to add their special Hate Crimes legislation is what really appears to be slowing down the enactment of this important legislation that is designed to protect children from sexual predators.

H.R.3132 Children's Safety Act of 2005 if approved by the U.S. Senate and signed into law by President Bush would primarily:

1. Provide the public with a National Database of Sex Offenders maintained by federal officials.

2. Require all sex offenders to register with this national database.
3. Provide punishment for offenders who do not register or fail to keep their registration current.
4. Authorize the use of U.S. Marshalls to locate sex offenders who flee from registration.

Authorizing the use of U.S. Marshalls to locate sex offenders who have fled from registration is one of the most important features of this legislation. Currently there are no major efforts to find these offenders who prey on children. Providing U.S. Marshalls to track down offenders will save lives.

PLEASE SEND THE ENCLOSED POST-CARDS OR WRITE A PERSONAL LETTER to encourage these senators to support prompt passage of the Children's Safety Act (H.R. 3132) WITHOUT the special Hate Crimes legislation demanded by homosexual activists.

PM and November 24th from 1:00 to 3:00 AM. "Inside the Playboy Mansion" is one of the most explicit programs FFA has ever recorded on an advertiser supported television network.

Many concerned citizens responded to FFA's email campaign by sending emails to thirty-three (33) officials with the thirteen (13) companies that advertised on A & E's "Inside the Playboy Mansion." These citizen emails voiced concerns to these companies regarding their advertising support for the explicit Playboy television program. Additionally, these citizen emails informed the advertisers that A&E was planning to air another two hour Playboy special called "Playboy's Celebrity Centerfolds" on Friday, December 2nd at 10:00 PM and Saturday, December 3rd at 2:00 AM.

GOOD NEWS! A&E did NOT air "Playboy's Celebrity Centerfolds." It appears the flood of emails that advertisers received regarding advertisements on "Inside the Playboy Mansion" influenced A&E to CANCEL "Playboy's Celebrity Centerfolds" that was scheduled for airing later that week on December 2nd and 3rd..

Although VH1 and A&E are owned by different companies FFA strongly believes that VH1's removal of "Centerfold Babylon" at the same time that A&E removed "Playboy's Celebrity Centerfolds" is no coincidence. This victory resulted from FFA's diligent efforts to confront pornographic shows on television and supporters who participated in FFA's email campaigns.

Despite the heavy loss of advertisers, the Entertainment Channel continued to air the Howard Stern Show with his explicit and degrading interviews of nude porn models. It appears that Comcast Corporation (owns 60% of E! Channel) and Walt Disney Company (owns 40% of E! Channel), were intent on keeping the pornographic Howard Stern Show on their network despite the significant financial loss from companies who avoided advertising during Stern's ten hours a week of airtime.

Howard Stern has signed a new contract with Sirius Satellite Radio for exclusive airing of his program. It appears this new exclusive agreement is the likely reason why Howard Stern's program was removed from the Entertainment Channel.

Florida Family Association invested significant time and resources during the past ten years to help influence the removal of the Howard Stern Show from unrestricted radio and television broadcasts. FFA wrote over 30,000 letters since August 1995 that influenced thousands of companies to stop advertising on his degrading show.

FFA's letter writing efforts to advertisers influenced the removal of the Howard Stern Show from WCLB in West Palm Beach, WTBB in Panama City, WTKS in Orlando, WBGW in Miami, All WB television stations nationwide, All UPN television stations nationwide and All CBS television stations nationwide.

Howard Stern was forced to move to subscriber based pay radio, Sirius, because the explicit nature of his program cost him a significant loss of advertisers, radio stations and television networks. FFA's ten years of consistently writing companies that advertised on the Howard Stern Show together with complaints filed with the Federal Communications Commission have finally paid off.

Howard Stern is no longer on television or any traditional broadcast radio station in America. This is a HUGE VICTORY for America's moral environment.
